The last pages of this newsletter are the purposed bylaw changes. Please look them over and be ready to discuss them at the next general meeting.

As you walk into the club house, you'll notice that all the old plastic chairs are gone, and the new folding chairs are there, and we also have a new chair rack that is on wheels to make setting up for meeting or training much easier. Also, Ed Hilkey is almost completed with the Berm fix by installing 77 concrete blocks between Bays 6 & 7 making it a permanent repair to the erosion there. Also listed are the names that painted the tabletops on the 100- and 200yard ranges and the short range and helped with the block install, great job and a thank you all: Kevin Turkington, Sigrid Johnson, Joe Goldstein David Penrod, Jason Hansen, Greg Speck and Don Struthers.

Randy Pike is heading up a new program called adopt a range like you see along the roadway. This will entail just maintaining the growth around the range to and pickup any trash and brass. The target and stands will still be done by working parties. This will also count as your working party and a sign will be put up with your name or company name of who maintains this range. More will be coming out as Randy gets it put tother more.

We had somebody remove the gong from the 200-yard range and duct tapped it to the top railing of the target frames on Saturday 29 July. Please, Please do not remove the gongs from where they are installed. One big reason is ricochet and that's why they are set in the tractor tire. The cost of replacing the frame is another reason not to move them. The frames are painted red because we don't want people shooting at them. Just wanted to mention this!

Treasurer's Report: Treasurer, Ralph Young, reports that we have \$149,735.24.00 in the bank. So far this year we have realized \$2,000.00 in match revenue. Expenses for the past month have been pretty light with only \$482.00 spent on facilities maintenance and \$120.00 for printing of range rules.

General Business Reports

Reading of Previous Minutes: Published in the 12 June Newsletter 2023

Treasurer: Property Tax Update: The club owns two pieces of property, tax IDs 1866 (14.74 Acres) and 1848 (6.38 acres), total 21.12 acres.

For 2024 the valuation of 1866 was raised 71.4%, \$100,000, to \$240,000. For 2024 the valuation of 1848 was raised 20%, \$54,282, to \$325,630.

Overall, that is an increase of 37.5% to \$565,630. 1848 has the structures. 1866 is all land. Total cash as of 24 July is \$148,983.31

Work Projects: Want to talk about giving money or something to Ukraine. BROUGHT ITEM UP FOR DISCUSSION AND BOARD MEMBERS APPROVED \$500.00 FOR MEDICAL SUPPLIES FOR UKRAINE Gary Winlund made a motion to give \$500.00 for medical supplies and Alex Jackson 2nd the motion Board voted to accept motion with no objections.

Need to update the board on installing the concrete blocks. Concrete blocks are being delivered on the 31st of July. 7/25/2023 talked to Berg Vault today and showed them where we will be unloading the blocks. talked to Ralph about putting deposits down on excavator and concrete blocks.

Want to update the board on new targets for the pits and some ideas on maintenance of the pits. winter and summer.

Informed all board members present that new target stands for pistol pits 2-5 were complete and all bottom bases have been painted. discussed about pulling all but two targets in for the wintertime so they do not get ruined by the weather. board members thought it was a good idea. 7/25/2023 all new target stands were installed in pistol pits 2-5

Want to find out about getting ruff cut lumber instead of finished lumber for targets frames. Board members approved getting rough cut lumber for target rebuilds to save the club money.

Want to talk about the new overhang for the short old range. Sometime in September we will have a special working party to build overhang for old short range.

Want to talk about changing the oil in the tractor and mowers every year instead of by hours used. The board approved changing oil in tractor and lawn mowers yearly instead of by hours used.

Want to talk about scouts using facility. I have been down at the club several times when the boy scouts held their meeting. Not recently though. But when I was there, they had a couple of people working on things, but the rest were just running around like it was free for all. It was not like that when I was in the scouts. You had a job to do and training to get accomplished. It was something I have thought about for a while. They are using the club for a hang out and that is about it. If they do not want to assist in doing projects for the club, or to get their shooting badge, there is no real reason to let them use the club. Now, do not get me wrong here. I am all for helping those who help themselves, especially the scouts who are in any other group. But in this case, I just do not see where we are helping them at all.

Gary Winlund stated he's been trying to work with the Boy Scouts to get their shooting Merit Badge for about six months with no movement from the Boy Scouts their leadership is just stating that the Boy Scout Council is not getting back to them with a decision. He has spent approximately \$100.00 out of his own pocket buying merit badge books and targets to supply the boy scouts to help them achieve this badge. Also, Alex Jackson provided 22 Ammo so they could qualify for their merit badge, which has gone missing. The 22 Rifles the club owns are authorized firearms that the Boy Scouts could utilize, and the club meets the requirements to help the troop achieve this merit badge. Also, with winter expenses and the club doesn't see any return for supporting them they do nothing to support the club and our ideas.

All board members approved of having the scouts find another place to hold their meetings. They will be notified to find another place to hold their meeting by 1 January 2024. Gary Winlund motioned that they find a new

C.W.S.A. - BYLAWS

ARTICLE 1 - MEMBERSHIP

Section A:

Membership in the Central Whidbey Sportsmen's Association (CWSA) shall be open to all citizens of the United States of America upon full payment of fees and dues. The immediate family of a member defined as the spouse, significant other and children under the age of 18 years, are automatically considered associate members of CWSA without voting rights and may be issued associate membership card status by request. Spouses only may pay half of the regular membership fees and become a voting member. Persons under the age of 18 will not be accepted for full membership; they may become associate members of CWSA as part of a family only. All new members will go through orientation brief before they are issued a fob key.

Section B:

In order to participate in any shooting activities, members and guests must be legally entitled to possess and operate a firearm under the laws of the USA and State of Washington.

Section C:

Direct adult supervision is required for any member or guest under the age of 18 using the clubhouse or any of the other CWSA facilities.

Section D:

Senior membership shall be granted to those members aged 65 and over who have been regular members of CWSA in good standing for the immediately preceding 5 years. The Executive Committee has the authority to grant senior members reduced membership dues and to remit dues of members for value received or for other considerations deemed in the best interests of CWSA.

Section E:

Valid membership in CWSA is further contingent upon accepting in its entirety the following pledge, which shall be printed on all membership applications and signed by all applicants and members.

CWSA PLFDGF

I certify I am a citizen in good standing of the USA; I am not a member of any organization or group having as its purpose the overthrow by force or violence of the Government of the United States or any of its political subdivisions; I have never been convicted of a crime of violence; and I can legally own, use, and possess a firearm; and if admitted to membership, I will fulfill the obligations of good sportsmanship and good citizenship.

Section F:

Effective 1 January 2021, all members and future members are encouraged to join and maintain membership in the NRA, although it is not required to be a CWSA member.

ARTICLE 2 - DUES

Section A:

All dues are due and payable on the first day of January each year. There will be a 10-day grace period to pay your dues after that time your key fob

will be deactivated and deny access to the facilities. If dues are not paid by said date, this will be cause for termination and loss of good standing. If you are a senior member with 5 years in good standing you will revert to a general member for 5 years. All new members are required to file with the Membership Secretary a New Membership Application form when applying for membership. The board of directors and executive members will adjust dues and fees as required. Annual working requirements are required by each member of the club once a year or they can be assessed fees and dues determined by the board of directors and the executive members.

Section B:

An initiation fee may be required of each member at the time of joining the association for the first time and/or for reinstatement.

Section C

A new member joining after the beginning of the calendar year or a military member returning following deployment, shall be entitled to pay 1/12 of the annual dues per month for each remaining month for that calendar year. In addition, deployed military members, who maintain active club membership, will receive credit for their deployed time towards the following year's membership.

Section D:

The following Board Members will not pay dues or provide an annual service project, due to the inordinate amount of time spent outside of meetings to properly perform their duties in the following positions: President, Vice President-1, Vice President-2 Secretary, Treasurer, Facilities Superintendent and Membership Secretary. Hopefully this will be an incentive for other club members to step up and fill these positions as officer's rotate out.

ARTICLE 3 - MEETINGS

Section A:

The annual meeting shall be held on the second Monday of January. The annual report shall be presented. The Executive Committee shall present the upcoming annual budget to be voted upon if it has not been presented at a prior meeting. The meeting shall start with the installation of Officers and Directors.

Section B:

The monthly meetings of CWSA shall normally be held at 397 Safari Rd Coupeville, WA 98277 on the second Monday evening of each month and shall basically conform to Robert's Rules of Order. The Board Member/ Executive committee meeting shall take place on the 4th Monday evening of each month. The meeting and program shall attempt to be concluded in 90 minutes in a smoke-free environment.

Section C:

Special meetings of CWSA may be held at any time upon the call of the Executive Committee, or upon demand in writing to the President stating the object of the proposed meeting and signed by not less than 20 percent of the members entitled to vote. Notice of the time, place and subject of any special meeting shall be sent via the USPS not less than 7 days before

the date fixed for the meeting. The place of such special meeting shall be fixed by the Executive Committee.

Section D:

Meetings of the Executive Committee shall be held at such time and place as the committee may determine. Special Executive Committee meetings may be held at any time on the call of the President or by any three members of the committee requesting in writing to the Secretary. The newly elected Officers and Directors shall be invited to an Executive Committee meeting before the annual meeting to help with the transition process in a nonvoting capacity.

Section E:

A quorum of all meetings of the entire membership shall be the members present plus 2 of the Officers.

ARTICLE 4 - OFFICERS AND EXECUTIVE COMMITTEE

Section A:

The Officers of CWSA shall consist of the President, Vice President-1, Vice President-2, Secretary, Treasurer, Membership Secretary, and such other Officers as shall from time to time be appointed or elected. This group, along with the Board of Directors, shall constitute the Executive Committee. In addition, the most recent past president shall serve on this committee for 1 year following his/her term of office. Officers and Directors shall be elected by ballot by the members present at the meeting in December. The nominations shall be accepted in both the November and December meetings. The nominees must be aware of the duties of these offices for which they are running and personally accept nominations. The term of office shall be 2 years for Officers and 4 years for Directors. All Officers and Directors shall be a minimum of 21 years of age.

Section B:

The Executive Committee shall have full power and authority to: Appoint and remove at its discretion all agents and employees of the association and prescribe their duties and compensation.

Make such expenditures as the committee sees fit; however, \$600.00 shall be the maximum per item unless a majority votes and declares that an emergency exists. A 2/3 vote of the members at any legal meeting may restrict the amount that can be spent on any single item by the Executive Committee without members' approval.

Manage and conduct the affairs and business of CWSA.

Section C

If half or more of the Executive Committee are present at a meeting of that committee, they shall constitute a quorum.

Section D:

The resignation of any Officer or Director may be accepted by a majority vote of the remaining members of the Executive Committee or of a majority of the members at a regular monthly membership meeting if that is where the resignation is tendered. If an Officer misses 4 meetings or a director misses 3 meetings in a calendar year, the Executive Committee may vote to send a letter of warning. If that person misses one additional meeting, the Executive Committee may choose to determine that a resignation has been tendered and may choose to accept the resignation.

Section E:

If a vacancy on the Executive Committee occurs, a replacement shall be nominated and elected by the membership at the next regular meeting, unless such vacancy occurs after 1 October and before election in December.

Section F:

The Executive Committee shall not have the authority to sell, convey, encumber, mortgage, hypothecate, transfer, assign, or otherwise dispose of any interest in the land of CWSA without the affirmative consent of its members. Authority must be obtained in writing by the majority of the entire membership at a special meeting called for that purpose. The Board of Directors shall immediately solicit the membership for a proxy vote of those unable to attend in person. The final count after the proxy returns and the vote of the members present shall be decisive and shall be the legal decision on the proposal.

ARTICLE 5 - DESCRIPTION OF POSITIONS

Election of any office does not confer upon any Officer any prerogatives other than as specified in the following descriptions of those positions. However, recognizing that all eventualities cannot be covered by a single document such as this, if a decision needs to be made that cannot wait for a meeting of members to decide, then a majority of the Officers and Directors currently available shall be adequate to make that decision. Such decisions, however, shall be made known to the membership at the next regular meeting.

Section A: PRESIDENT The President shall preside over all meetings of the CWSA and the Executive Committee. He/she shall be an ex-officio member of all regular and special committees. He/she shall perform all such duties as usually pertain to the office, including assuring that all members, Officers, and employees perform their duties in a businesslike manner. He/she shall act promptly upon receipt of any correspondence or other action items received in his/her capacity as president. The president will assign a member of the club to hold Orientation for new members. The President is a 2-year term who will be relieved by Vice President -1 when his/her term is up unless the president wants to extend their term and is approved by the Board of directors and the executive committee.

Section B: VICE PRESIDENT-1

The Vice President shall perform the duties of president in his/her absence or at his/her request. The Vice President shall also conduct such regular and special duties and activities deemed appropriate by the President or the membership. The Vice President shall also coordinate the activities of all the various elected or appointed committees to include setting up and coordinating the annual charity match. The Vice President-1 will relieve the President when the President's 2-year term is up unless the President extends their oath of office at which time the Vice President-1 can choose to end his/her position or extend their position as well.

Section C: VICE PRESIDENT -2

The Vice President-2 Shall perform duties of the Vice President-1 in his/ her absence The Vice President-2 shall also carry out such regular and special duties and activities deemed appropriate by the President or the membership. The Vice President -2 will replace Vice President-1 when Vice President-1 moves to the President position. The Vice President-2 will chair the auditing committee along with 2 middle directors and 1 Officer to conduct an audit of the clubs' finances in June and in December of treasury records provided by the treasurer to include make a book of accounts together with cancelled checks, invoices, deposits and sources of monies available to the Executive Committee in order that it may ascertain the status of the treasury for budgetary forecasting or auditing purposes. The June audit will report to the membership its finding in July and the December audit will report at the January or February General Meeting with

the Treasurer giving his annual report to club members.

Section D: SECRETARY

The Secretary shall prepare correspondence as directed by the President or Executive Committee or on the vote of the membership. He/she shall notify the appropriate members of meetings when requested. He/she shall keep a true record of the minutes of the regular, Executive Committee, and special meetings. He/she shall be responsible for keeping the association's Certificate of Incorporation current with the Washington Secretary of State. He/she shall also carry out such duties that may be deemed appropriate by the Executive Committee or the regular membership',.. The Vice President-1 shall function as membership Secretary in his/her absence.

Section E.: TREASURER

The Treasurer shall have control and custody of all funds that come into the association and shall place them in such bank(s) as the Executive Committee directs. He/she shall keep an accurate account of all transactions and shall present a report with available receipts/vouchers at each Executive Committee meeting. The Treasurer will have financial information available to the members at each regular meeting. The Treasurer's report (at a minimum) shall include the savings account balance, the beginning checkbook balance, a list of sources of monies deposited, a list of checks written to whom and for what, and the ending checkbook balance. The checkbook balance and the bank's statement must be reconciled monthly. He/she shall also be responsible for paying all the association's bills in a timely manner and have a key to the post office box. The Treasurer is responsible for custody of the safe deposit box and coordinating access and contents with the Officers, Executive Committee and Directors as specified in ARTICLE 5, SECTION G.

The Treasurer shall from time to time, upon request of 2 Officers or 2 Directors, make a book of accounts together with cancelled checks, invoices, and sources of monies available to the Executive Committee in order that it may ascertain the status of the treasury for budgetary forecasting or auditing purposes. He/she will check the post office box weekly and coordinate with the membership secretary to ensure mail is picked up in a timely manner.

The Treasurer must also present an annual report to the membership no later than the first meeting in February. Two middle-term Directors and 1 Officer shall audit this report between the January and February meetings before it is presented to the general membership in February.

There shall be two additional Executive Committee members who shall have signatory powers for the checking account (generally the President and a Director) and 1 additional member who shall have signatory power for the savings account (a Director).

Section F.: MEMBERSHIP SECRETARY

The Membership Secretary shall actively solicit new members and process all applications for membership and maintain all records pertaining to membership in this association. He/she shall be the custodian of all unused membership cards and keys and issue them at the appropriate times. He/she shall communicate directly with the Treasurer to receive information of who paid, when and how much. He/she shall keep a current list of the members and shall furnish it to any Officer upon reasonable request but maintain strict confidentiality. He/She will assist the treasurer and check the post office box at least once a week and distribute mail as required. He/she shall also receive any grievances from the members and follow the proper procedures to resolve them or refer them to the Executive Committee. The Vice Prersident-1 shall perform the duties of the Membership Secretary in his/her absence.

Section G. : COMMITTEE CHAIRPERSONS

The Committee Chairpersons shall be appointed by the President or by consensus of the members for a period of 1 calendar year or for the duration of a specific project. They may be removed from their jobs by the same process. They shall be responsible for all functions and enforcement of all rules and regulations involving their activity. They shall direct or appoint as needed additional committee members to assist in the successful running/completion of said activity. They shall contract no bills without the specific authorization of the Executive Committee or the membership except the spending of their approved budget. Committee spending shall not exceed the budgeted amount unless authorized by the Executive Committee.

The Standing Committees are the following:

RANGE: Responsible for range rules and safety on all active ranges, including planning.

FACILITIES SUPERINTENDENT: Responsibilities include maintenance of all CWSA facilities and grounds to include fences and barriers, equipment, such as, mowers; vehicles; and tractor.

PUBLIC RELATIONS: Acts as liaison with public media to promote awareness of association activities and future events.

SHOOTING EVENTS: Schedules and supervises special events whether "association only" or open to the public.

FUNDRAISING: Accountable for fundraising, including raffles and any other authorized event or method.

NEWSLETTER: Publishes the monthly newsletter providing calendar events and pertinent information of interest to members.

POSITIVE ACTION: Enhances the image of the association in the community and county and promotes awareness of the positive aspects of shooting sports.

SOCIAL: Schedules events on an annual basis to promote social interaction and entertainment of members and families.

MEMBERSHIP: Actively solicits new members through liaison with the Public Relations and Newsletter Committees.

HUNTER SAFETY: Provides educational opportunities through approved and authorized courses open to the public.

Section H.: BOARD OF DIRECTORS

Directors shall be members in good standing elected by the membership. The Board of Directors shall consist of 8 Directors each to serve a term of 4 years. Two Directors will be elected every other year to provide for staggered terms unless fewer or more elections have to occur to maintain a board of 8 Directors. In addition, the Facilities Superintendent shall serve as a voting director during his/her tenure in office and shall attend all meetings of the Executive Committee.

They shall be part of and attend all meetings of the Executive Committee. They shall be responsible for auditing the accounts of the association in June and December. One of the audits shall be performed as in ARTICLE 5, SECTION D above with the data provided from the Treasurer in a timely manner. The Audit Committee will be formed by the Vice President-2, 2 middle-term Directors and 1 Officers and will review the CWSA financial records in compliance with accepted accounting principles. The Facilities Superintendent shall be excluded from auditing responsibilities. The access to the safe deposit box shall be as follows: If no Director has access, the Director with the longest amount of time remaining on his/her term shall obtain access. This same individual shall also obtain signatory power for the association's monetary accounts and shall act in the Treasurer's absence.

The board shall review the bylaws annually and discuss any changes with the Executive Committee before presenting them to the membership for adoption, always in writing. Any changes or amendments must have a two-thirds majority vote of members at a legal meeting to pass. The bylaw Committee will be formed by the 2 Directors having the least time to serve on the board and will comply with provisions of ARTICLE 9—AMENDMENTS.

The board is also responsible for forming a Nominating Committee to present a proposed slate of Officers for the ensuing year. The Nominating Committee will form in October with the 2 Directors having the second to the most time to serve on the board plus 1 member at large and will follow the procedures in ARTICLE 4, SECTION A.

ARTICLE 6 - SUSPENSION OR EXPULSION

Section A: OFFICERS AND DIRECTORS

Any Officer or Director may be removed by a two-thirds majority vote of the members in good standing at any legal meeting called for this purpose. No vote on suspension or removal may be taken unless at least 15 days' notice in writing shall have been given to the Officer or Director of the reason for his/her removal and the time and place of the special meeting at which such ballot is to be taken unless the Officer or Director in question waives his/her right to be present at that special meeting. The President (or Vice President-1 if the President is the subject) shall make sure that the Officer or Director receives a full and fair hearing.

Section B: ANY MEMBER

Charges against any member may be preferred by any member in good standing. They shall be in writing clearly stating the facts relied upon and accompanied by all affidavits or exhibits that are to be used in their support. Such charges shall be filed with the Membership Secretary, who will immediately attempt to resolve the issue. If unsuccessful, he/she shall notify the President within 5 days. The President (or Vice President-1 if the President is the subject) shall immediately call a meeting of the Executive Committee to hear the charges.

The Membership Secretary will give at least 15 days' notice of the meeting to the members of the Executive Committee, the accuser, and the accused (who shall both attend). The notice shall be in writing and will include a true copy of the charges and supporting documents. The Executive Committee shall resolve the issue, if at all possible. Otherwise, it shall either dismiss the charges as being of little or no consequence. or direct that a general-membership meeting be called as listed in Section A above. Upon expulsion, there shall be no refund of dues or any part thereof.

ARTICLE 7 – AWARDS

CWSA SPORTSPERSON OF THE YEAR shall be presented to the individual exemplifying the spirit of sportsmanship and upholding the bylaws of CWSA. This person demonstrates the ideals of a family association supporting conservation, public awareness, social responsibility, and firearms safety through shooting events. The nominations for the individual shall be submitted to the Executive Committee at the November and/or December meetings, and after selection by the Executive Committee will be awarded at the annual meeting in January.

ARTICLE 8 - DISSOLUTION

In the event future circumstances require CWSA to discontinue operations, the following procedure will be followed by then elected Officers of the association:

A) The following elected Officers shall constitute the "Dissolution Administration Committee" (DAC):

President

Vice President-1

Vice President-2

Secretary

Treasurer

B) Liquid assets shall be disposed of as follows:

Any outstanding debts and/or bills shall be paid first before any further disbursements. Member dues shall be reimbursed pro-rata for the remainder of the calendar year when the association facilities will no longer be available for members' use. Remaining liquid assets shall be distributed to selected Island County charities as determined by the DAC and approved by the Executive Committee.

C) Chattel assets shall be disposed of as follows:

Association chattel property shall be auctioned to the membership. Any property not auctioned shall be gifted to selected charities. Auction proceeds shall be included with the liquid assets defined in B) above.

D) Real Property:

Association real property shall be deeded to the Island County Historical Society County Sheriff's, or such other deserving entity as determined by the DAC and approved by the Executive Committee.

ARTICLE 9 - AMMENDMENTS

Any proposed amendments to the bylaws may be submitted in writing to the Executive Committee at any time. The committee shall deal with them in an appropriate and timely manner depending on the subject of the proposed amendment. If they receive the committee's approval, they must be voted on by the members at a regular meeting provided the members have received a copy of the changes at least 7 days before the meeting. A two-thirds vote of the members present is required for any change to the bylaws by email.

By-Laws were amended by a vote of the membership on 13 December 2021 30 June 2023.
