IMPORTANT LAW CHANGES FOR GUN BUYERS IN WASHINGTON STATE YOU SHOULD KNOW ABOUT

I received this email from Jerry Mumfrey from Ace Hardware!

"Larry,

As promised, a bit late, attached is a word document summary of the upcoming change to firearms background checks January 1st. Although I couldn't say it directly, however, you might want to consider sending the message... if you want to buy a firearm without all the restrictions and requirements of E2SHB 1143... BUY YOUR FIREARMS NOW. DON'T WAIT UNTIL THE LAST MINUTE.

When the Assault Weapons Bill was under development and review, I did my best to ensure that my customers knew that the bill was going to be effective immediately. However, there were a few who waited until the last minute, and I ended up having to return those firearms back to the place of purchase.

The message is \dots 'READ AND HEED' don't get caught short.

During a recent meeting with the CWSA President, we had an in-depth discussion on some important changes to the firearms background check process in the state of Washington. As one of your local FFL agents, he asked me to share those changes heading your way.

As some of you may or may not be aware, in addition to the Governor signing the House Bill affecting the sale and/or transfer of the "assault weapons" back on April 25th, 2023, he also signed the Engrossed Second Substitute House Bill (E2SHB) 1143. This bill will have a DIRECT IMPACT on ALL FIREARM BACKGROUND CHECKS beginning January 1st, 2024.

In the past, firearm background checks when down one of two paths: an ATF NICS check (ATF Form 4473) or a local law enforcement agency (police or sheriff department) check which had jurisdiction based on your local residence. Between now and January 1st, FFL districts are being transitioned to the Washington State Patrol (WSP) background check system. Locally, here in Island County, that transition took place in September. So now, all firearm checks go directly to the WSP. You will still fill out the ATF Form 4473, and that information is transmitted directly to WSP for the background check. So, between now and the end of December, once your background check is approved and a "PROCEED" is transmitted to the FFL agent, your firearm can be delivered to you. The only exception to this is Semiautomatic Rifles, which require a **mandatory 10 business day** waiting period prior to delivery.

Beginning January 1st, 2024 here is a brief highlight of the changes that will have a direct impact on your purchase and/or transfer of a firearm in this state.

- A firearm dealer <u>MAY NOT</u> transfer a firearm until the background check is completed. This means no longer will FFL's be able to transfer a firearm before they receive a "PROCEED" response from WSP.
- 2. ALL FIREARMS will now have a **mandatory 10 business day** waiting period prior to delivery, not just semiautomatic rifles.
- 3. A dealer shall charge a purchaser or transferee a background check fee in an amount determined by the WSP.
- 4. Requires firearm dealers to obtain proof that the transferee has

completed a recognized firearms safety training program within the past 5 years. "The proof of training shall be in the form of a certification that states under the penalty of perjury that the training included the minimum requirements." (E2SHB 1143). There are exemptions for law enforcement and "certain" military members. Those military members "who, as part of the applicant's service, has completed, within the last five years, a course of training in firearms proficiency or familiarization that included training on the safe handling and shooting proficiency with firearms." (E2SHB 1143). So, if your military training record can't prove it, than you will have to take the "recognized firearms safety training program".

"The training must be sponsored by a federal, state, county, or municipal law enforcement agency, a college or university, a nationally recognized organization that customarily offers firearms training, or a firearms training school with instructors certified by a nationally recognized organization that customarily offers firearms training."

- "...a recognized firearms safety training program...at a minimum, includes instruction on:
- Basic firearms safety rules.
- Firearms and children, including secure gun storage and talking to children about gun safety.
- c. Firearms and suicide prevention.
- d. Secure gun storage to prevent unauthorized access and use.
- e. Safe handling of firearms.
- f. State and federal firearms laws, including prohibited firearms transfers and locations where firearms are prohibited.
- g. State laws pertaining to the use of deadly force for self-defense; and
- h. Techniques for avoiding a criminal attack and how to manage a violent confrontation, including conflict resolution." (E2SHB 1143).

All the above is just a summary of the important changes to the purchase and/or transfer of firearms in the state of Washington beginning January 1st, 2024.

OFFICER POSITIONS NEEDED ASAP TO BE FILLED

We are in need to fill the following club positions as of 31 December 2023. I will step down as President and it would be great if somebody stepped up to the plate to run the club! I will stay on as your advisor for one year to help you take over as president giving you a complete turnover with files. The vice President's are in place to ensure we have a even turnover every two years and we need to fill those positions as well! Please help the club out by volunteering for one of these positions!

Section A: PRESIDENT

The President shall preside over all meetings of the CWSA and the Executive Committee. He/she shall be an ex-officio member of all regular and special committees. He/she shall perform all such duties as usually pertain to the office, including assuring that all members, officers, and employees perform their duties in a businesslike manner. He/she shall act promptly upon receipt of any correspondence or other action items received in his/her capacity as president. The president will assign a member of the club to hold orientation for new members. The President is a 2-year term

who will be relieved by Vice President -1 when his/her term is up unless the president wants to extend their term and is approved by the Board of directors and the executive committee.

Section B: VICE PRESIDENT-1

The Vice President-1(VP-1) shall perform the duties of president in his/her absence or at his/her request. The VP-1 shall also conduct such regular and special duties and activities deemed appropriate by the president or the membership. The VP-1 shall also coordinate the activities of all the various elected or appointed committees to include setting up and coordinating the annual charity match. The VP-1 will relieve the president when the president's 2-year term is up unless the president extends their oath of office at which time the VP-1 can choose to end his/her position or extend their position as well. The VP-1 will fill in for the Secretary in their absence.

Section C: VICE PRESIDENT -2

The Vice President-2 (VP-2) Shall perform duties of the (VP-1) in his/her absence. The VP-2 shall also carry out such regular and special duties and activities deemed appropriate by the president or the membership. The VP-2 will replace VP-1 when VP-1 vacates the position. The VP-2 will chair the auditing committee along with 2 middle directors and 1 officer to conduct an audit of the clubs' finances in June and in December, using records provided by the treasurer: to include account books, cancelled checks, invoices, deposits, and sources of monies available to the Executive Committee. The semiannual audits shall ascertain the status of the treasury for budgetary forecasting. The June audit will report to the membership its finding in July and the December audit will report at the January or February general meeting with the treasurer giving his annual report to club members, The VP2 will fill in for the Membership Secretary in their absence.

General Business Reports

Reading of Previous Minutes: Minutes from previous meeting posted online.

Treasurer: We received \$603.00 in match fees this month. We are running at \$2800.00 for the year in match revenue. This is a big drop compared to last year. We need to come up with ideas to improve this situation.

Ron brings up again that we need to work with Holms Harbor and invite them to our matches to improve our participation.

Ralph mentions that it is the end of the year, and we need to review our budgets. Currently we have \$1000.00 in a recruitment budget. In addition, we are having difficulties in member retention. What can we use this budget for to improve retention and to attract new members? Larry mentions that we could use some of this money for advertising our matches. Membership: Wes Kenworthy reports that we currently have 919 members according to EZ-F with 151 new members for the year. Club members need to talk to their friends and ask them to assume club leadership. Wes mentions that we are trying to get everyone to sign up online and use their credit cards for membership renewal.

Public Relations: Not present.

Work Projects: We are pretty much caught up will all of our outstanding work projects, except for doing some maintenance on the short range. Ed is holding off on that until he finishes a couple of small projects. Everything is looking really good. We are having some problems with deer chewing the bark of some of the trees.

NRA Membership: Gary will be taking this over from Linda.

NRA Training: Gary Winlund is taking over the NRA training program.

RSO Report: Not present.

Old Business

Discuss dates and times for membership renewals. Wes reports that we are trying to get everyone to use the online registration. Wes has eight days set up in November and December to handle the walk-in renewals. Currently we have about 400 members that have accounts on EZ-F. Hopefully, we can get more people to set up an account. Kirby says that we will send out an E-mail inviting members to set up accounts. Larry suggests that we set 17 February as our last face-to-face renewal.

Kirby mentions that 1 March is the deadline for renewal before a late fee is invoked. Also, we have a new-member orientation set up on 13 January. Ron Martin made a motion to accept Wes' proposed dates. The motion was seconded by Kirby Stevens. And passed by the membership.

One suggestion is to use one of Ed's pictures and post it at the range with a statement about improper target placement.

The December board meeting needs to be moved to the 18th of December to avoid having a meeting on Christmas. This will be Larry's last meeting as president. Mark your calendars.

Al Lindell: Future club administration: How is the club going to be administered if no one steps up to run for president. Things do come up that Larry has had to handle. We need to take a look at this and have a plan to move forward so that critical club business can still go on. Items that do come up need to be brought to the board to get resolution. Al mentions that what we are doing now isn't working. We have been working on this for six months and we only have two months left before the end of the year.

Repay Ron Martin for club patches: Kirby made a motion to repay Ron \$250.00 for the patches he purchased. The motion was seconded by Ed Hilkey and passed by the board.
